Cost of Terms and Conditions in Collective Bargaining Agreements

The cost of contract terms and conditions as a percentage of wages and fringes was little changed in 2009 at 6.5 percent. The contract items included in this measure are now valued at \$3.17, up somewhat from the prior year. Dollar costs rose since the cost of many language items is dependent upon wage rates which have increased.

The cost of terms and conditions in collective bargaining agreements has been tabulated from the Construction Labor Research Council data base of labor cost information. A fixed set of job conditions are applied to the terms and conditions and wage and fringe rates of each local labor contract in order to quantify the cost impact of the terms and conditions. Using these job conditions permits consistent comparisons between contracts over a period of time. As a result, these data are not comparable with any other known information relating to non-union labor costs or manufacturing labor costs.

Overtime payments account for the largest portion of additional costs (\$1.30). Unlike many items, overtime is, to some extent, dependent upon job site management and may, sometimes, be advantageous. The other items with relatively larger additional costs are show-up pay and time paid, not worked (coffee breaks, clean-up, etc.).

Among individual agreements, there is a wide range of costs of terms and conditions. Contracts are almost equally likely to have costs anywhere from 4 up to 10 percent with a few higher. Dollar costs of specific contracts also vary widely but a majority are less than \$3.50.

Trends

Year-to-year trends in this data series are small as contracts are generally renegotiated only once every several years. Even when renegotiated, dramatic changes in language are uncommon. It is evident, though, that the long-term trend of terms and conditions costs as a percentage of wages plus fringes continues to be steady to downward. Patterns are similar to earlier years, but with dollar costs moving higher.

Improvements in individual agreements have a small impact upon the national averages. They can, however, have a significant effect upon costs in a particular agreement. These changes continue to be negotiated.

Regional Characteristics

The cost of terms and conditions as a percentage of wage and fringes varies moderately by region. All regions are within one percentage point of the national average except two (one higher and one lower than the United States average). Four regions are clustered between 5.9 and 6.4 percent.

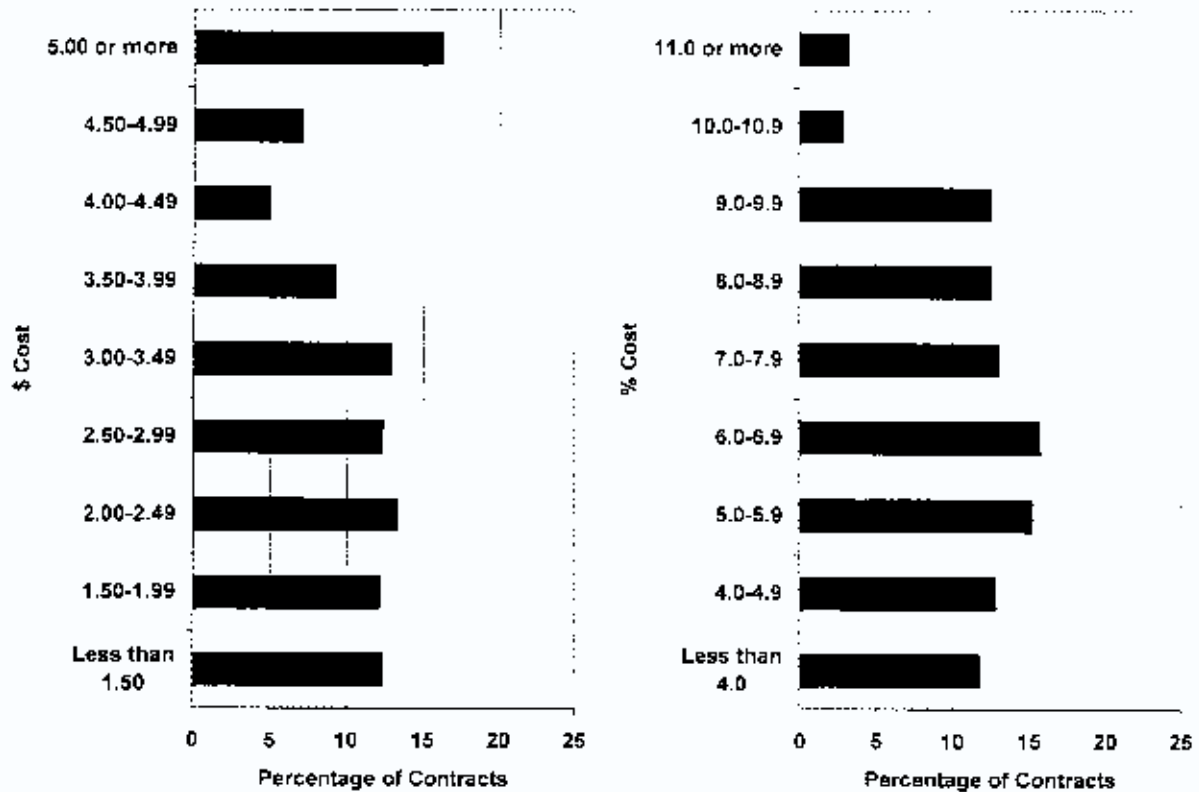
Craft Characteristics

The cost impact of contract language varies more widely between crafts. Many are more than one percentage point from the national average. The all crafts average is reduced because carpenters and laborers, the crafts with the greatest number of workers, have the lowest prevalence of most of the items adding to contract costs. The cost for these two crafts is less than 6.0 percent.

Other Factors

The findings in the report are industry averages. The cost of terms and conditions in a specific contract can vary significantly both higher and lower from these averages. These costs can be reduced by negotiating language changes at the bargaining table. The cost on a particular job site may also vary significantly from that which has been determined in these calculations because averages reflect the cost experience of a combination of situations, not a particular one. Furthermore, other payments, not included in the collective bargaining agreement may also exist.

The assumptions applied to each contract such as annual hours, amount of overtime, prevalence of travel pay, etc., are CLRC estimates. They are based upon typical situations in particular areas and the experience of many within the industry. Again, because they are averages, they do not reflect area and craft differences that are known to exist. It is important to recognize, however, that varying the assumptions applied, although changing the calculated costs, does not change the conclusions. For example, a particular craft that has high non-wage and fringe costs with the assumptions used in this report is still relatively high with alternate assumptions.

These data exclude another sizeable group of labor related costs - legally required payments. Included among this group of costs are social security, unemployment insurance tax and workers' compensation insurance. Social security, alone, will exceed 7 percent of base wage costs for most employees and workers' compensation may be even higher. Each of these costs is calculated as a percentage of base wage, so that its cost increases as wage rates increase.

2006 - 2010

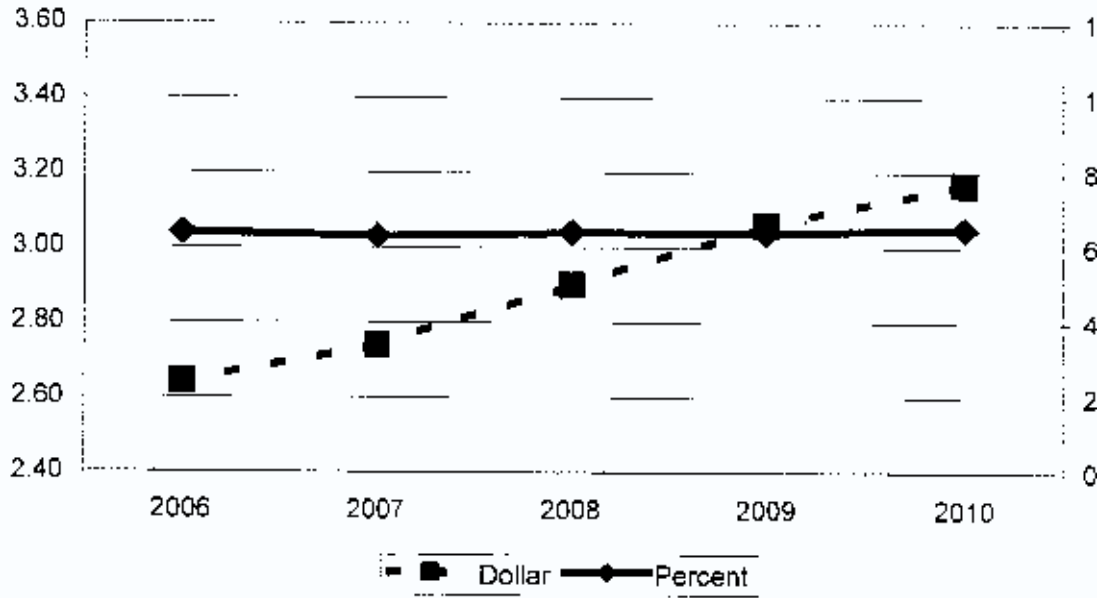
